### Directions

**From South:** Garden State Parkway North to Exit 168. Keep right onto Washington Ave. Slight left onto Westwood Ave. Right onto Harrington Ave. Enter Westvale Park on the right.

**From North:** I-87/NY State Thruway to Exit 14. Garden State Parkway South to Exit 168. Follow direction from South.

**From West:** Route 208 South to Route 4 East to Route 17 North to Garden State Parkway North. Follow directions from South.

**From East:** I-95 South to George Washington Bridge upper level. Stay right over bridge to Route 4 West via Exit 72A. Forest Ave exit, bear right. Forest Ave becomes 4<sup>th</sup> Ave. Slight right onto 3<sup>rd</sup> Ave. Right on Washington Ave. Slight left onto Westwood Ave. Right onto Harrington Ave. Enter Westvale Park on the right.
